## The Recidivism Reduction (Re-entry)

Program is designed to support individuals who are planning their transition back into their community or have recently released from incarceration. Our Case Manager works one-on-one to connect clients with resources, including assistance in three major areas: Housing, Employment, and Treatment. For those who qualify, this can include assistance with paperwork, coordinating services, transportation assistance, etc. Services are provided through “Transition Plans”, created between you and your Case Manager, focusing on your individual goals. Transition Plans are created during the initial appointments and updated post release and during the 3rd and 6th month in the program.



## Housing

The program will work with DOC to utilize programs such as Alaska Housing Finance Corporation's (AHFC) Returning Home Program. The program will connect clients to appointments with AHFC, utilize case management to follow up on their applications for vouchers, and connect clients to housing that fits their needs. Frontier Community Services has a Behavioral Wellness Case Manager who has an established relationship with the local AHFC, follows up on voucher applications, and has a community resource list of landlords that accept Alaska Housing who the Recidivism program employee can utilize. The Case Manager can assist with applications to transitional housing that is available within the community.

## Employment

Appropriate referrals would also be made through the Division of Vocational Rehabilitation (DVR) for preparing for, obtaining, and stability in employment. If a referral for additional employment assistance is needed, the Case Manager will assist with the appropriate referrals. Case Managers can aid in the creation of basic resumes and information on available positions within the community, focusing on employers who hire employees with legal barriers. Clients can be assisted with going into the community to job search, gaining access to the local Job Center, or making and attending interviews if needed.

## Treatment

The program will assist clients in identifying and connecting to local treatment resources and the necessary documentation required for assessments and treatment.

## Who qualifies for the program

The Recidivism Reduction program target population are those who have served more than 30 days of incarceration and are within 90 days of release from a DOC facility and are medium to high-risk felony offenders or high-risk misdemeanor offenders based on DOC's Level of Service Inventory-Revised (LSI-R) risk assessment.

The LSI-R score is generated by your internal field Parol/Probation Officer. Sex offenders, regardless of LSI-R scores, and individuals identified by Probation Officers who require assistance in the community may or may not be on probation or parole. The population served will be those in or transferred to the Kenai/Soldotna area.

### Please reach out to see if you qualify for services based on these categories:

- Served a minimum of 30 days
- Within 90 days post-release
- Medium to High Risk based on LSI-R scoring
- Sexual Offenses regardless of LSI-R scoring
- Transitioning to release in the Kenai/Soldotna area
