WHO PROVIDES NOCM NURSING SERVICES?

NOCM services are provided by a registered nurse employed by a certified NOCM provider agency. The NOCM nurse will develop a nursing plan for inclusion in a recipient's waiver support plan. In addition, the NOCM nurse will develop and implement a plan to train the recipient and the recipient's caregivers regarding how to perform the medical care tasks necessary to meet the recipient's needs.

- Nursing visits are conducted in the recipient home and frequency is determined according to the complexity of the health care needs.
- NOCM visits are completed once every three months at a minimum.



HOW DO YOU QUALIFY FOR NOCM SERVICES?

To qualify for these services, the recipient must be eligible for a Children with Complex Medical Conditions, if over the age of 22, or the Individuals with Developmental Disabilities.

Qualifiers include:

- Dependence on medical care or technology to maintain health.
- Periodically experiences acute exacerbation of a severe medical condition that requires frequent or life-saving administration of specialized treatment.
- Dependent on mechanical support device

WHAT DOES A NOCM NURSE OFFER?

Complex medical needs can often overwhelm families and care providers. NOCM nursing collaborates with Care Coordinators to ensure the Plan of Care (POC) goals are being supported, evaluated, and enhanced. This collaboration keeps the focus on patient centered goals, strengthening

caregivers understanding of care, providing education to help with decision making, which ultimately leads to improved outcomes. This process includes but is not limited to:

- 1. Nursing assessment of the recipient's medical care needs
- 2. Support waiver Plan of Care (POC) with a Nursing Care Plan addressing:
 - a. Health and safety
 - b. Medical care needs
 - Training required for paid/ unpaid caregivers to perform DELEGATED nursing duties
- 3. Participate in planning the recipients care in accordance with the POC.
- 4. Provide oversight by evaluating whether services:
 - a. Are delivered in accordance with waiver Plan of Care in a manner that protects the health, safety, and welfare of the recipient
 - b. Are reasonable and necessary for recipients medical condition and complexity of the care required to treat the condition
- 5. Remaining in contact with recipient with frequency appropriate to the condition and complexity of care delivered:
 - a. At least 1 home visit every 90 days
 - b. These visits include the recipient and any individual to which nursing duties were delegated as well as designated family members.
